1) RECREATION SITES AND TRAILS:

- Initiated the establishment of the Lakes Outdoor Recreation Society (LORS)
- LORS Mandate to keep local recreation sites and trails open and maintained
- Donated \$25,000+ annually to this end

Recreation sites and trails program

- LORS is a not-for-profit society
- LORS holds Directors and Officers Liability insurance
- Recreation sites and trails liability covered under government policy (registered trails and recreation sites)
- Partner with Ministry of Forests, Lands and Natural Resource Operations

Challenges

- Funding, funding, funding
- Government stopped funding program in 2001 (provides some support – project-based, infrastructure)
- Funding, funding, funding

Successes

- Awesome support from Recreation Sites and Trails Branch (Kevin Eskelin)
- Some of the `best maintained` recreation sites in the north
- Social and economic benefit to our community



2) RECREATION EVENTS:

- Sponsor a variety of recreation events (cross-country skiing, snowmobiling, adventure challenges, logger's sports, etc.)
- Each group organizes own event and holds insurance we just provide funding!



2) CROSS-COUNTRY SKIING:

- Worked with local ski club to construct trail, re-routed trails to accommodate salvage activities
- Provided in-kind mapping services
- Developed biathalon range



4) SNOWMOBILING:

- Worked with local snowmobile club to construct 30 km new trail north of Burns Lake
- Provided in-kind mapping services and project supervision
- Provided funding for annual events



5) MOUNTAIN BIKING:

- Purchased 160 acres of private land for Bike Park development
- Purchased mini-excavator for trail construction (provided free of charge)
- Donated \$100,000 seed money to mountain bike club
- Burns Lake Mountain Bike Club
 has built world-class trails, now
 hosts annual events such as the *Big Pig*, hosts bike camps and
 workshops, and has received
 international attention
- 8-page spread in the international *BIKE* Magazine

 Kevin Eskelin, of Recreation Sites and Trails BC was recently chosen to receive a Premier's Award for innovation for his work with BLMBA and other bike clubs









WHY SUCCESSFUL?

- Dollars from BLCF to get "product" on the ground (maintenance, new trails, etc.)
 \$1.1 million+ to date to recreation
- Dedicated group of volunteers (LORS, BLMBA, BLSC, OSC)
- All trails registered/approved and built to Whistler Trail Standards according to the agreement with the government
- Awesome support from government staff
